EXPLANATION AND SUPPLEMENTATION OF TENDER DOCUMENTATION - I.

Contracting Authority of the over-threshold public contract “**Deliveries of security paper, security paper with applied holographic stripe and thermal paper with applied holographic stripe**” being awarded in an open procedure pursuant to Act No. 134/2016 Coll., On Public Procurement, as amended, hereby explains and supplements the tender documentation in accordance with § 98 and § 99 of the Act.

Question 1:

In the tender procedure Deliveries of security paper, security paper with applied holographic stripe and thermal paper with applied holographic stripe in its part C) there is a requirement for supplies of thermal paper with applied holographic stripe

Please indicate for each type of thermal paper whether the holographic strip should be applied from the active or inactive side?

Answer to question 1:

The Contracting Authority confirms the current awarding conditions. The holographic strip application is on the non-thermolayer side.

Question 2:

In the Annex no 1 we can find security features which are very general:

- physical protection UV
- physical protection IR
- plungers/planchettes

Please send additional explanation of them.

Answer to question 2:

Contracting Authority hereby specifies the security features:

Physical protection UV

- paper is illuminated on one side in UV (paper contains optically brightening agents and on one side is UV radiation matt coating (so-called fluorescence killer = UV killer)

Physical protection IR

- in the paper there is a pigment reacting to the IR detection pen (antistoke pigment)

Plungers/planchettes

- the supplier must also be able to offer planchettes in paper

Question 3:

Protective fibres listed in the Annex no 1 are 1, 3 and 6mm whereas the most standard length of the fibres is: 3 mm and 5 mm. Could you please limit the length of the fibres only to these lengths i.e. 3 and 5mm?

Answer to question 3:

The Contracting Authority confirms the current awarding conditions. We also insist on fibers with a length of 1 mm.

Question 4:

In the Section A of Annex 1 it is requested to submit the extra charge for cutting in sheets whereas the format of the sheets is not specified. As the cost of the cutting depend on the cutting format please specify it.

Answer to question 4:

The Contracting Authority completes the current awarding conditions. Format of the sheets shall be 500 x 700 mm or 450 x 650 mm.

Question 5:

In the Technical Specification in Annex 1 the number of discontinuities per roll is specified as max 1. Could you please consider extending this number to 2 (two)?

Answer to question 5:

The Contracting Authority confirms the current awarding conditions. We insist on one break per role.

Question 5:

It is requested that companies from outside Czech republic submit the Czech certificates (tax, social registry). Could you advise is these certificates for foreign companies can be

received in any authority in Czech republic or only some designated? If you have a sample please send.
