## **Question 1:**

Requirements for Basic Capacity outlined in section 9.2 of Tender Documentation: Section 9.2.1 parts a) to e) are covered in Annex 3a. We notice that in section 9.2.2 and 9.2.3 reference is made to section 8.2.1, which does not exist in the tender document. Please can the Contracting Authority clarify?

### Question 2:

There is also a requirement to provide written affidavit for 9.2.3 b) & c) that relates to 8.2.1 - Should this also be included in Annex 3a along with the signature of the authorized person?

## **Answer to question 2:**

Relevant phrasings regarding 9.2.3 b) (ie. non-existence of payable tax arrears on excise duty) and c) (ie. non-existence of payable tax arrears on insurance premiums or public health insurance penalties) have been already included in the pattern of written affidavit stated in

For this test, we a more recent version, Golden Reader Tool Platinum Edition version 3.12.0.7, is this acceptable for STC?
