## ALTERATION OF TENDER DOCUMENTATION - II.

The Contracting Authority of the over-threshold public contract „**Production and Supply of Chip Prelaminates**“ being awarded in an open procedure pursuant to Act No. 134/2016 Coll., On Public Procurement<sup>1</sup>, as amended (hereinafter referred to as “Act”), hereby alters the tender documentation in accordance with Sec. 99 of the Act.

After further assessment of the applicable definition of security material as derives from the “ISO 14298 Management of security printing processes” and “CWA 15374 Security management system for suppliers to the security printing industry” and the following internal guidelines of the Contracting Authority and subsequent consideration of all tender conditions the Contracting Authority has decided to change the tender conditions as follows.

### a) Changes in the document named Tender Documentation itself

- The change lies **in removing the required conditions for fulfilling the technical qualification, specified in Section 9.4.2 of the Tender Documentation.**
- In connection with this change, Section 15.3 of the Tender Documentation shall be also removed from the Tender Documentation.
- Further in connection with this change, **Annex No. 6 – “Affidavit on Security Requirements” and Annex No. 8 – “Security Audit Requirements”** shall be removed from the Tender Documentation.

Due to change of numbering in the Tender Documentation and to ensure a clear arrangement of the documentation the Contracting Authority hereby published a new revised version of the whole Tender Documentation as Annex 1 hereof, **in a visible revision mode.**

### b) Changes in the Draft Framework Agreement (Annex no. 1 to the Tender Documentation)

- The change lies **in removing several of the provisions in Art. XIII of the Draft Framework Agreement.**

- Further in connection with this change, **Annex No. 3 – “Security Audit Requirements”** shall be removed from the Draft Framework Agreement as well as other connected provision.

Due to change of numbering in the Tender Documentation and to ensure a clear arrangement of the documentation the Contracting Authority hereby published a new revised version of the whole Tender Documentation as Annex 1 hereof, **in a visible revision mode.**

The Contracting Authority considers the above-mentioned alterations as a case where the scope of possible participants may be extended by the alteration or supplementation of the procurement documents so the Contracting Authority extends the time limit for tenders submission by its entire original length.

Time limit for the submission of tenders:

- **original time limit for the submission of tenders:** until 26. 01. 2021 9:00 AM
- **new time limit for the submission of tenders:** until 03. 03. 2021 9:00 AM
- **opening of tenders:** after the expiry of the limit for the submission of tenders
