Regarding these parameters we can undertake the following parameters:

- Grammage: tolerances about +/-4 mm

- Thickness: tolerances about +/- 10 mm

- Absolute humidity: tolerances about min 5 max 7

Concerning these afore-mentioned parameters could we have a possibility to extend the tolerances?

Answer to the question No. 1.:

The Contracting Authority has decided to extend the required parameters in the technical specification, which is Annex No. 1 to the Draft Framework Agreement, which is Annex No. 1 to the Tender Documentation, as follows:

- Grammage: tolerances about +/-4 g/m2
- Caliper (Thickness): tolerances about +/- 10 µm
- Absolute humidity: tolerances about min 5, max 7

The Contracting Authority considers, that the supplier stated incorrect units in his inquiry. Corrected units are marked in red in this answer.

The Contracting Authority attaches an updated technical specification, which is Annex No. 1 to the Draft Framework Agreement, which is Annex No. 1 to the Tender Documentation.

Question No. 2.:

We herewith would kindly like to ask for a filing extension of the submission deadline for the above mentioned tender.

Due to the pandemic it takes longer to obtain all the necessary documents at the moment therefore we would appreciate if you could extend the submission deadline at least to March 19th.

Answer to the question No. 2.:

Due to the alteration of conditions in the Tender Documentation, the limit for tenders submission will be extended by its entire original length, see below.
