

**WRITTEN REPORT OF THE CONTRACTING AUTHORITY****„Supply of Polycarbonate ID1 Prelams with Contactless  
Chip Modules for Electronic Residence Permit Cards (eRP)  
and Electronic ID Cards  
(eID)“**

In accordance with the Sec. 217 of Act No. 134/2016 Coll., on public procurement, as amended (hereinafter referred to as the “Act”) the Contracting Authority has made this written report on the above-mentioned over-threshold public contract for supplies to be awarded in an open procedure by the Act.

The subject of this public contract is the Contractor's obligation to supply to the Client, according to its current needs, non-personalized polycarbonate ID1 prelams with initialised contactless chip modules equipped with ICAO travel application for eID and eRP (hereinafter referred to as the “**Prelam**”), including its testing version according to the technical specification contained in Annex 1 to the Framework Agreement (Annex 1 of the TD).

The subject of this public contract is also the Contractor's obligation to implement the specific initialisation of the contactless chip Prelam software, described in classified information in accordance with technical specification contained in Annex 1 of the Framework Agreement and Client's instructions (Key management and transport ceremony between inlay supplier and Client, Transport key diversification), provided by the Contracting Authority after signing of the Framework Agreement (hereinafter referred to as the “Implementation of the Key ceremony”).

**Reason for selection:**

In accordance with the provision of Sec. 114(1) of the Act, the basic evaluation criterion for the award of this public contract was the economic advantageousness of the tender.
