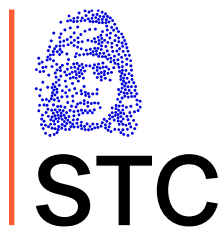
### EXPLANATION OF TENDER DOCUMENTATION III.

The Contracting Authority of the over-threshold public contract called „**Production and supply of prelaminated card inlays with windows for ID1 cards\_reissue // Výroba a dodávky předlaminátů s okénkem pro ID1 karty\_opakování**“ being awarded in an open procedure pursuant to Act No. 134/2016 Coll., On Public Procurement, as amended (hereinafter referred to as “Act”), hereby explains the tender documentation in accordance with Sec. 98 of the Act.

<b><u>Question No. 1:</u></b>	<b><u>Answer to the question No. 1:</u></b>
Is there approximate quantity?	Approximate quantity for the duration of the contract is 250 000 pcs. (806 500 EUR/3,226 EUR).
<b><u>Question No. 2:</u></b>	<b><u>Answer to the question No. 2:</u></b>
This tender doesn't include chips and magnets?	No, the subject of this public contract does not include chips and magnets.
<b><u>Question No. 3:</u></b>	<b><u>Answer to the question No. 3:</u></b>
Must be filled in Czech language? Your document is mainly in English.	According to the Art. 17.2 of the Tender Documentation, the tender shall be submitted in the Czech and English language, or its combination.
<b><u>Question No. 4:</u></b>	<b><u>Answer to the question No. 4:</u></b>
What does it mean? Note that administrative fee of 100 CZK shall be paid. In accordance with the Czech legal system it may take up to 30 days the certificate to be issued.	The Contracting Authority believes that the supplier is inquiring about the issuance of a request for a debt-free confirmation from the Czech tax office, as one of the conditions for fulfilling the basic capacity (Art. 10.2.3 a) of the Tender Documentation).  Yes, this request requires a fee of 100 CZK.  This confirmation is not submitted by the supplier in the tender but is required in the cooperation phase before signing the contract.

<b><u>Question No. 5:</u></b>	<b><u>Answer to the question No. 5:</u></b>
May I ask what is the black printed marks?	The specification – position + dimensions + shape of the black printed marks is mentioned in the Attachment no. 2_Positions_Transparent window CZ with registration marks v1.0_230308 (Annex No. 2 of the Technical specification). The marks mean black crossings, which is used for registration of sheet during collating process.
<b><u>Question No. 6:</u></b>	<b><u>Answer to the question No. 6:</u></b>
The red Czech map is on the film or on the card?	The red colour of the contour of the map of Czech Republic is used for highlighting the desired shape of the transparent window and the transition between white and transparent polycarbonate. No red colour/ red printing on the prelaminated inlay with transparent windows is required.
<b><u>Question No. 7:</u></b>	<b><u>Answer to the question No. 7:</u></b>
This supply card in this tender includes Makrofol® ID layer? For both sides including front and back?	All material which is used for production of prelaminated inlay with transparent windows has to be compatible with Makrofol® ID material according to the Annex 1 of the Draft Contract ("Technical specification").
<b><u>Question No. 8:</u></b>	<b><u>Answer to the question No. 8:</u></b>
1 sheet(3*5pcs) is not cut into pieces when delivery right?	Yes. The layout of required sheet for delivery is in the Attachment no. 2_Positions_Transparent window CZ with registration marks v1.0_230308 (Annex No. 2 of the Technical Specification).
<b><u>Question No. 9:</u></b>	<b><u>Answer to the question No. 9:</u></b>
So, one box contains 6*96*1 sheet(3*5pc) right?	One sheet means one prelaminated sheet 295x330 mm with 3*5 (15) positions of transparent windows as it is specified in the Attachment no. 2_Positions_Transparent window CZ with registration marks v1.0_23030. So, one box contains 6*96 of these sheets.

The Contracting Authority does not consider this explanation as alteration or supplementation of the tender documentation whose nature would demand extension of the time limit for the tender submission in accordance with Sec. 99 (2) of the Act, since the Contracting Authority does not alter the tender conditions.
