Or is a special security liquid ink requested?

Nr.:	Answer of the Contracting Authority:
1.	<ul style="list-style-type: none">- 3 pieces of impact printing boxes are required in total.- 1 piece OCR-B1 installed in the Device.- 1 piece OCR-B1 as a spare one;- 1 piece Code 39 Barcode (to replace installed OCR-B1 in case of need).
2.	No, the impact printing number will be printed only ones in a booklet, i.e. it will be applied on front endpaper or first visa page or back endpaper.
3.	Additional impact printing box (OCR-B1) is understood as a spare one.
4.	<p>It depends on a design of printing box and ink application, i.e. it could be printing ribbon as well as liquid ink. The only requirement is possibility to choose application of black color or black color with UV fluorescence.</p> <p>If it is a tape, the Contractor shall guarantee delivery for the lifetime of the offered Device. It is also part of the guaranteed consumables supply.</p>

Conclusion:

The Contracting Authority does not consider this explanation as alteration or supplementation of the tender documentation whose nature would demand extension of the time limit for the tender submission in accordance with Sec. 99 (2) of the Act, since the Contracting Authority does not alter the tender conditions.
