1.1. The subject of the public contract

The subject of the public contract is the Contractor’s obligation to produce and supply to the Contracting Authority agreed quantity PC Prelaminates with chip modules containing required types of chip modules, or with defined combinations of types of chip modules according to Art. II (2) of the Draft Contract and transfer to the Contracting Authority ownership of the supplied Prelaminates.

1.2. The price agreed in the public contract
