 Background: Chapter 5 of the TD stipulates an estimated value of the Public Contract of <u>8 million EUR</u> excl. VAT The "Evaluation Model" (Annex 5) of the tender calculates a total price for <u>30 years lifetime</u>, while chapter 2 of section V "Price" in the "Draft Contract" (Annex 1a) only summarizes the total price for 1 machine (incl. transport, installation, documents and training) Question: Please confirm that the estimated value of <u>8 million EUR</u> excl. VAT refers to the total price in section V "Price", chapter 2 of the Draft Contract. 	The Contracting Authority confirms that the estimated value is 8 milion EUR excl. VAT.	
	This estimated value includes all possible costs for the acquisition and operation of the Device for a 30-year lifetime (cell C20 of Annex No. 5 to the Tender Documentation "Evaluation Model").	
	In the Draft Contract, the prices will be indicated only for the lifetime of the Device, which the supplier states in his tender.	
	Therefore, in the Draft Contract in Sec. V (2), only the price for one Device will be indicated.	
	According to this explanation the Contracting Authority does not confirm that the estimated value of 8 million EUR excl. VAT refers to the total price in Sec. V (2) of the Draft Contract.
