EXPLANATION OF TENDER DOCUMENTATION III.

The Contracting Authority of the over-threshold public contract called "Supply and Service of the Enveloping Machine for ID1 Cards // Dodávka a servis obálkovací linky pro ID1 karty" being awarded in an open procedure pursuant to Act No. 134/2016 Coll., On Public Procurement, as amended (hereinafter referred to as "Act"), hereby explains the tender documentation in accordance with Sec. 98 of the Act.

Question No. 1:

According to the Explanation of tender documentation II we do understand that matching option of the additional documents from the additional stations is not required. Therefore, additional personalized documents would not be processed. Regarding the International driver's license, which is a personalized document and it's a minority in the production we do recommend leave out the task of processing it. Inserting of additional personalized documents and it's correct match with the cover letter printed from the database with an address for delivery without applying any matching logic is a security problem. Becide a security problem there is no control, if the Internation driver's license and cover letter are paired correctly in the envelope.

Based on above we are asking Contracting authority to reconsider to keep the processing of international driver's license in the tender documentation. In our opinion, the technical specification must be clear so that the potential supplier must be sure, that the offered solution meets or does not meet the requirements of the Contracting authority.

We do recommend simply write down that the Contracting authority is requiring station/stations which are able to process the A4 sheets with folding options and inserting variety of marketing leaflets.



Answer to the question No. 1:

The contracting authority does not intend to change the technical documentation and the principle of attaching the attachments. We still require the functionality of attaching a product in the format of an international driver's license without any needs for pairing with the cover letter. Thank you for your opinion and description of security risks that we are aware of. In practice, we will not send a real personalized international driver's license processed on this equipment. With this request, the contracting authority only wanted to ensure the possibility of attaching a marketing product in the format of an international driver's license without any personalization.

Conclusion:

The Contracting Authority does not consider this explanation as alteration or supplementation of the tender documentation whose nature would demand extension of the time limit for the tender submission in accordance with Sec. 99 (2) of the Act, since the Contracting Authority does not alter the tender conditions.
