EXPLANATION AND CHANGE OF TENDER DOCUMENTATION II.

The Contracting Authority of the over-threshold public contract called "Device for hot foil stamping, embossing and die-cuttin // Zařízení pro aplikaci hologramů, násek a výsek" being awarded in an open procedure pursuant to Act No. 134/2016 Coll., On Public Procurement, as amended (hereinafter referred to as "Act"), hereby explains the tender documentation in accordance with Sec. 98 and 99 of the Act.

Questions about document Annex No. 3 of the TD – "Evaluation Model"	
Question No. 1:	Answer to the question No. 1:
To "1. Evaluation Model Complete", 3a - 3c: we suggest carrying out one service check every year. Such a check takes one working day (approx. 8 hours). Does your "Price per unit" include only the working hour price of our technician or is it intended incl. travel and accommodation costs? • If it is not intended incl. travel and accommodation costs, where do these costs have to be taken into account?	The Contracting Authority confirms that "Price per unit" includes only the working hour price of the supplier's technician. The "lump sum" according to the to Art. V (5) point d) of the Draft contract is used to price the supplier's "additional" costs such as travel and accommodation costs of the technician, etc., both for preventive inspections and maintenance, and for out-of-warranty maintenance. The limitation stated in cell B18b (item No. 6.) of the Annex No.3 – Evaluation Model ("when conducting unscheduled servicing on the Device") was stated by mistake and was corrected by the Contracting Authority. The supplier is obliged to use these revised documents in its tender ("Annex No.3 – Evaluation Model rev1").
Question No. 2:	Answer to the question No. 2:



To "1. Evaluation Model Complete", 4a - 6c: the figures in the column 'Estimated quantity (for 15 years)' between 8 and 40 hours, where do they come from? I'm not sure, for example, whether you only need a service technician for 40 working hours within 15 years (!).

The Contracting Authority states that the stated quantity of hours is based on an estimate and experience with servicing production devices. The data is for evaluation purposes only and is not binding.

Question No. 3:

To "1. Evaluation Model Complete", 6: the travelling and accommodation costs depend on how long a technician's intervention takes, and during an unscheduled intervention you do not beforehand know, how long it will take.

Answer to the question No. 3:

This item includes the cost of travel to STC and any accommodation, where different suppliers may have different prices. Please, fill in the price from the average data for servicing similar production devices (i.e. mainly length of stay) from your experience so far.

Question No. 4:

To "2. Annex 9 Contract_Spare parts": There are only 19 lines that cannot be extended. That is far too few. In any case, wear parts can hardly be defined in a reasonable way, as their wear depends on countless factors, not just the number of operating hours. To give an idea of what may need to be replaced once or possibly several times in 5 years, I can only provide a kind of recommended spare parts list. This may or may not be needed, but it is the best guide. In any case, 19 lines are not enough, I would need about 60. Can you expand the document or provide a new template for download?

Answer to the question No. 4:

The Contracting Authority states that the supplier has correctly understood that it is to provide a list of recommended spare parts and extends the number of cells for filling in recommended spare parts and consumables to 60, for every 5 years.

The supplier is obliged to use these revised documents in its tender ("Annex No.3 – Evaluation Model rev1").
