#### Question No. 3:

#2: "The Contractor acknowledges that he has the obligation to obtain the necessary permits to enter the city centre, if necessary..."; For a foreign, medium-sized company, it is extremely difficult or even impossible to obtain a permit without local support, possibly to be able to drive into a city centre with a heavy transport or even to have roads closed so that the machine can be unloaded. When we delivered a machine to the Hungarian Banknote Printing Shareholding Company in Budapest or to the National Bank of Serbia in Belgrade, the customer made that effort. As a state institution, it was no problem at all to obtain all the necessary authorisations and permits. Can this be adapted in the contract so that you take care of the possibly needed authorisations and permits?
