1 Introduction

This annex aims to describe the detailed structure of information to be exchanged in the context of the COPIS Project.

Chapter 2 "Message representation template" is the model used to describe the content of the information to be exchanged.

In this model, the information to be exchanged is defined as messages which are organised into data groups which contain data items.

The model allows identifying:

- the characteristics of the data groups belonging to the message: sequence, number of repetitions, a state value to indicate if the data group is mandatory, optional or conditional;
- the characteristics of the data items belonging to a data group: sequence, number of repetitions, type, length and a value to indicate if the data is mandatory, optional or conditional;
- data group indentation indicates that the data group may contain not only data but also other groups of data;
- the conditions applicable to data or groups of data towards other data or groups of data in the same message;
- the structure rules applicable to data or groups of data, explaining how the data or data group in question is used in the message;
- the code lists applicable to data items, referring to the appropriate list of values that the specific data item may take.



The functional message structure is presented using the structures presented hereafter.



At the top of the page (heading section), the following elements are encountered:

a) The message identification code following the naming convention:

Domain	Prefix	Numbering	Usage / Description

- b) The message name (e.g. INSERT AFA);
- c) The message short code/name (e.g. C_COP_AFA) prefixed with 'C_' which means common domain message type.
