

**WRITTEN REPORT OF THE CONTRACTING AUTHORITY****„Laminating Press Delivery“**

In accordance with the Sec. 217 of Act No. 134/2016 Coll., on public procurement, as amended (hereinafter referred to as the “Act”) the Contracting Authority has made this written report on the above-mentioned over-threshold public contract for supplies being awarded in an open procedure by the Act.

The subject matter of this public contract was the Contractor's obligation to supply 1 piece of a Laminating Press, including all other related accessories and equipment, manufactured under applicable EU directives and regulations related to the subject of the Draft Purchase Contract and in line with the technical specifications attached to this Contract as Annex No. 1, which is an integral part of the Draft Purchase Contract (hereafter referred to as the "Device").

The subject of this public contract also included the:

- a) transportation and moving of the Device to the determined Buyer's facility and place of installation, including liability insurance which provides cover for damage to the device, with a compensation limit as determined in the TD, DAP Praha (Incoterms® 2020),
- b) installation and commissioning of the Device, including 30 calendar days of its test run,
- c) training of specified Buyer's employees in the Device operation and maintenance for at least 5 persons (hereinafter referred to as the "operator training"), conducted at the Buyer's facility for a minimum of 3 business days (8 hours per day, 60 minutes per hour),
- d) handover of certificates and documents relating to the use of the Device, as specified in Annex No. 2 which is an integral part of the Draft Purchase Contract (in particular, operating and maintenance instructions, technical documentation in the Czech language).
