## 1.1. The subject matter of this public contract

The subject matter of the public contract is the undertaking of the Contractor to supply the actually required <u>50% Cotton Security Paper</u> (hereinafter referred to as the "Goods") in compliance with the technical specifications stated in the tender conditions of the tender procedure and in Annex 1 to the Draft Framework Agreement (annex 1 of Tender Documentation), and further, to allow the Contracting Authority to assume property title to the supplied Goods.

The design with exclusive watermark authored by the Contracting Authority shall be provided by the Contracting Authority to the Contractor within 15 calendar days after signature of the Draft Framework Agreement.

Further definition of the subject of performance of this public contract is provided especially in Annex 1 of Tender Documentation – Draft Contract.

In accordance with the Sec. 36 (4) of the Act the Contracting Authority states that no part of the tender documentation has been drafted by a person other than the Contracting Authority.

#### Reason for selection:

In accordance with the provision of Sec. 114(1) of the Act, the basic evaluation criterion for the award of this public contract was the economic advantageousness of the tender. The Contracting Authority set out the following evaluation partial criteria based on which the economic advantageousness of tenders shall be assessed:

The Contracting Authority evaluated the tender prices in EUR excl. VAT, **stated in the tenders in the Annex no. 2 of the Draft Framework Agreement**, individually in each evaluation sub-criterion on a scale from 0 to 100. Each tender was assigned a score under each evaluation sub-criterion, which reflected the rate of success of the respective tender in terms of each evaluation sub-criterion. For all sub-criterions, under which the most advantageous tender has the minimum value of the sub-criterion, the assessed tender have been assigned a score, **calculated as the ratio of the most advantageous tender to the assessed tender multiplied by 100.** 

The score reduced by the weight of each sub-criterions has been used for total evaluating the tenders, i.e. the individual scores of tenders under these sub-criterions have been multiplied by the weight of the relevant sub-criterions.

Based on the evaluation the Commission stated the following order of the tenders:
